1. Approve August's minutes:

Shearon moves to approve; Willa seconds it. Nancy asked if anyone objects and nobody did, so it passed.

2. Always keep in Mind: Revenue streams, Research, Value-Added for Members, Quality

3. Treasurer's Report – Jan

Jan submitted notes before the meeting. See notes in blue below. We had a good couple of months but we spent more money than we brought in. We still have about \$23,000 in our bank account.

[We had some nice income from Intensive Weeks during both months: \\$2800 in July and \\$5680 in August.](#)

[Expenses were light in July and August, so we had net gains of \\$500 in July and \\$5300 in August Year-to-Date we are at a negative \\$8200, which means we've spent that much more than we've taken in. Last year to date, we were at a positive \\$4800. \(This is not shown on the spreadsheet.\)](#)

4. GQS Update (Bob): We are in a good place where we now have a solid rubric. We just need to figure out things like activities, videos, etc. We should have some revenue so that we can have a running website. Later on as we advance it will require visits for external evaluations as well. So it comes down to percentages and how much WGI and WGI-US get. There will be an application for Glasser Quality Schools and Glasser Quality Educators. There are ways to generate income from this. Let's think about how much we are charging as well. Nancy suggested talking about it within the committee and then bringing some choices to the board. There is a first page of a website that is already written. It will be sent to us in the next couple of days.
 5. 2017 in person meeting (Kim): Kim thinks meeting in person at the beginning of the year is important because of relationship building. We will potentially have 3 new board members in 2017 and Kim thinks it's important to meet in person. Willa suggested a PDF explaining board policy to replace the in person meeting. Bob asked a question of us: in the last 3 years, which new board members read the PPM? There are some concerns about expenses and how much we spend on these meetings. We are expecting to be listed as evidence based by the end of the year so that might help too. Kim brought up the fact that WGI is in the same predicament; where some members think we cannot afford it. WGI also talked about asking member organizations to pay \$500 a piece for their reps. The US has 3 reps, so that would mean paying \$1500 for our reps to go. Vote: "WGI-US is able to support the 2017 in person meeting by paying \$500 per representative (total of \$1500 from the US)". WGI has not agreed to financially support the 3 representatives for the WGI 2017 meeting.
 6. MHH (Kim): Nancy has been working with MHH alongside with Ken Larsen. After Ken passed away and Nancy got sick, it became difficult to keep up with the blogs. Kim and Nancy decided not to do the MHH summit this year. Nancy has plans to rebuild and revise MHH and perhaps find some ways to generate some income from MHH. Nancy is asking for \$1000 a month for 7 months to do this. Kim went to WGI and asked the executive committee to support this and some executive board members offered to cover this (Canada and Japan are willing to pay \$250 each). Kim thought if Canada and Japan are contributing, maybe the US can contribute. At that time Columbia offered to help with \$250 a month as well. We are missing \$250 so Kim is wondering if the US can help out and contribute \$250 a month for 7 months. We asked what the money is being used for. Nancy talked about how much of time and effort it takes to run MHH. It takes time to go out and solicit people and edit blogs as well as the challenges. It takes a minimum of 10 hours a week to upkeep with this and Nancy is unable to do this on a voluntary basis at this point with her health and energy level. The reality is that she is unable to keep doing it for free anymore at this time. Sue clarified that we are creating an ADHOC paid position for 7 months. It's \$1000 for about 40 hours of work. What happens if MHH goes away? MHH has brought more activity and outsiders than anything else has in several years. Have people signed up for basic weeks because of it? No. Bob is willing to talk to Nancy about looking at subscription levels and charging a certain amount. Nancy says she has all that planned out. If we create this position, what will be fulfilled? In the next 7 months, what will be accomplished? Nancy will send that to us. There is a worry about setting a precedent and other people who also volunteering time. Nancy left the meeting at this time so that we could talk about this. In that

case, do we then need to pay Denise for MHH administrator stuff? We have not paid her for MHH work except for the once a year summit admin work.

This was brought up during the WGI executive committee; not the WGI board meeting. Bob asked if there was a way where other countries could also be asked. If the US does not contribute, the other three countries will still contribute. Given the data and given the plan, do we want to create an ADHOC position? We are going to table this until October. What information do we want for October?

-Are we getting any income from it? We have had very little income from it this year.

Terri needed to leave at this point. Her concern was that we don't have a precedent for this currently. Kim clarified that the board doesn't hire people; only the Executive Director would hire people. The board hires the ED.

Jan left at this point.

This has been tabled for next month after we get the proposal.

Summary:

We have been able to maintain our present state despite the challenges starting with Ken's death in February and my illness (being down and out for 4 months). Denise has done a terrific job maintaining the site, primarily drawing from previously written and posted blogs. (I'd like to give recognition and personal shout out to Mike who continues to write and submit blogs — thank you Mike.)

Our immediate challenge facing us is October 10, 2016, World Mental Health Day a la the World Health Organization. The last two years we have presented our Mental Health & Happiness Summit; 24 world wide interviews of experts, life story tellers, and practitioners. Ken was integral with the IT of these productions, (as well as interviewer and interveiwee). Our plan for 2016 is to present the "best of" repeats from previous years. We still need to get the word out via social media and announcements. During this year's Summit we will provide 24 hours of designated videos available to anyone who registers. Participants can then view the videos they choose, during the time that they choose. (Plans for next year's summit is included in the proposal to follow.)

As always there is need for more authors to write blogs and produce vlogs (video blogs — again see proposal). In April "call for blog authors" was sent out via WGI-US with very good responses. Unfortunately this occurred at the same time I became so ill. I was able to capture some, and am now going back to reconnect with others. There will be a repeat of this action, now to include all of WGI, especially Japan, Columbia, and Canada. (see below)

We are now receiving monthly contributions/payment to me for doing this work. \$250.00 each is contributed by Canada, Japan, and Columbia from September to March, 2017. There is a proposal for USA to

contribute the same amount, to be discussed at another time during this meeting.

We continue to receive new subscribers to the Challenges, as well as continued feedback from appreciative readers.
