- 1. Dave Betz: Dave resigned from the board. He's contributed a lot to the board and pushed us along. In his honor, we would like to keep the momentum going. Keeping that in mind, Kim and Jan had a couple of meetings.
- 2. Strategic Planning
  - a. Marketing Committee: Kim, Shruti. Nancy, Jan
    - a. Face to face Board Meeting: Kim and Jan discussed the face to face meeting. They would like this to be a working meeting where the time is used to create products for WGI-US. This can help us create revenue and earn some money.
    - b. Faculty Retreat: Similarly to the face-to-face board meeting, we would use the faculty retreat time to have a working group to create products. Instead of calling it a faculty retreat, what if we called it a product development think tank? Or a think and do tank.
    - c. Thriveworks: He would want us to own the trademark of William Glasser and Choice Theory. We can probably do some of the things he was recommending.

- d. Josh Covey: Kim got a call from him. He is interested in Choice Theory. He will attend a basic training and Kim will go to one of his 2 day trainings. They will then compare notes and see how they can work together. As a side note, Nancy Herrick let us know that the VHS videos of Dr. Glasser are being digitized.

- 3. Approve September minutes: Nobody objected to approving September's minutes. The minutes were approved.
- 4. Choose people to keep in Mind: Revenue streams, Research, Value-Added for Members, Quality
  - a. Revenue streams: Jan
  - b. Research: Willa
  - c. Value-Added for members: Jim
  - d. Quality: Marty
- 5. Conflict of interest (Willa): Willa sent out a conflict of interest page that she copy/pasted from university guidelines. Willa thinks we should consider a conflict of interest policy for WGI-US, and Kim pointed out that we do have a conflict of interest policy and directed the board to the Policies and Procedures Manual. Willa thinks the policy needs revision, with attention given to revising three separate items (mentioned by board members during discussion) in the Manual. She is concerned that board members and employees/contractors should not be considered as applicants for paid trainings organized by the board, unless no one else meeting criteria applies. The decision was made to make no changes at this time. Once the present rubric has been fully approved and adopted, the questions regarding conflict of interest will be addressed again to see if there are any remaining unaddressed issues needing clarification or change in the policy.
- 6. Request to board from Cesar: Would like to consider offering a Lifetime Achievement award to Hoeffine (unsure of last name). She was the 2<sup>nd</sup> person trained by Dr. Glasser and is now 98 years old. Cesar will send an email to Kim and Kim will issue a plaque. The board agreed to this by unanimous consent.

- 7. Research Committee vote (Janet): Willa reported that NREP got back to them about some of the questions they had. They are trying to track down some data. NREP is continuing to evaluate the packet that Janet submitted.
- 8. Database (Denise): Denise was able to answer questions that the board had about the database. The finance committee wanted to know if we could send reminder emails about membership payment. Denise clarified that the database stores training, member information, and not much else. The system cannot send invoices. We can do this with emails. Another

thing we can do is send 3 reminders instead of just 1 email. We can also consider having a late fee or give a discount to people who pay on time.
